The Company and third parties or tied agents acting on its behalf, may use your personal information:

- To perform identity and/or money laundering and/or fraud prevention checks;
- To perform credit checks by contacting any financial institution or credit facility;
- To send you text messages and/or email communication regarding, inter alia, trading alerts, margin calls or other information relating to your trading account.
